

ORDINANCE 2025-05-003

AN ORDINANCE OF THE CITY COUNCIL OF THE TOWN OF PINE ISLAND, TEXAS, CANVASSING ELECTIONS AND DECLARING RESULTS OF THE GENERAL ELECTION SCHEDULED FOR MAY 3, 2025 FOR THE PURPOSE OF ELECTING A MAYOR AND ONE (1) COUNCILMEMBER TO SERVE FOR A TERM OF TWO (2) YEARS; AND PROVIDING FOR THE FOLLOWING; FINDINGS OF FACT; REPEALER; SEVERABILITY;EFFECTIVE DATE; AND PROPER NOTICE & MEETING.

WHEREAS, on February 4, 2025, the City Council of the Town of Pine Island (“CITY”) adopted Ordinance No. 2025-02-04 calling for a General Election on May 3, 2025, to elect a Mayor and one city Councilmember to serve in at-large place positions, each term consisting of two years; and

WHEREAS, on March 4, 2025 the City Council adopted Ordinance No. 2025-03-004 cancelling the general election and declaring the unopposed candidates as elected; and

WHEREAS, section 67.003 of the Texas Election Code, as amended, generally provides that each local canvassing authority shall convene not later than the eleventh (11th) day after the election date for the purpose of canvassing the election results; and

WHEREAS, section 67.004(a) of the Texas Election Code, as amended, establishes the quorum level required to canvass election results and provides that two (2) members of the canvassing authority constitute a quorum for purposes of canvassing the election; and

WHEREAS, pursuant to directions from the Secretary of States Election Division, a final canvass is required for cancelled elections prior to certificates of election being issued to candidates declared unopposed; and

WHEREAS, it appears to the Council, and the Council finds, that the attached results of the election are true and correct.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF PINE ISLAND, TEXAS:

Section 1. Election. The General Election of the Town of Pine Island, Texas for May 3, 2025, were duly called, and that notice was given when said elections were cancelled in accordance with the law. The certifications and cancellation notice of the General Election for May 3, 2025, for the purpose of electing one (1) Mayor and one (1) Commissioner, Place 1 to two (2) year terms, copies of which are attached to and made a part of this ordinance, are adopted as the official final canvass of the election, and will be filed and recorded in the official records of the Town of Pine Island, Texas, as the official canvass results.

Section 2. Canvassing the Election. The official canvass of the election reflect the following:

Mayor	Steve Nagy- UNOPPOSED
Commissioner, Place 1	Karen Payton- UNOPPOSED

Section 3. Election Results. The City Council officially finds and determines and declares the results of said election reflect the following:

Mayor	Steve Nagy
Commissioner, Place 1	Karen Payton

The above-named persons are hereby duly elected at said election and shall take their respective offices upon their qualification therefore, as provided by the laws of the State of Texas.

Section 4. Authorization to Execute. The Mayor of the Town of Pine Island is authorized to execute, and the City Secretary is authorized to attest this Ordinance on behalf of the City Council. The Mayor is further authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 5. Repealer. All ordinances, or parts thereof, that are in conflict or inconsistent with any provision of this Ordinance are hereby repealed to the extent of such conflict, and the provisions of this Ordinance shall be and remain controlling as to the matters regulated, herein.


Section 6. Severability. Should any of the clauses, sentences, paragraphs, sections, or parts of this Ordinance be deemed invalid, unconstitutional, or unenforceable by a court of law or administrative agency with jurisdiction over the matter, such action shall not be construed to affect any other valid portion of this Ordinance.

Section 7. Effective Date. This Ordinance is effective immediately upon its passage and approval.



It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Texas Government Code, Chapter 551. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.

Election Code. The following candidates have been certified as unopposed and are hereby elected as follows:


